A. CALL TO ORDER

Mayor Vlasisavljevich called the meeting to order at 4:08 p.m.

B. NEW BUSINESS

1. Approve Nursing Home Lease between City of Eveleth and EHSP, Inc.

Salene explained that the lease is a capital lease. EHSP will be responsible for all the maintenance and capital improvements of the leased area.

Motion by Councilor Koivunen, second by Councilor Hadrava to approve the Nursing Home Lease between City of Eveleth and EHSP, Inc. Ayes – All.

2. Approve Letter of Agreement Between The City of Eveleth, MN and Base Unit, The American Federation of State, County and Municipal Employees, AFL-CIO, Local Union No. 484

Monahan-Junek stated that the personnel committee is recommending that the new hire starting wage be below the contract amount because the new hire does not meet all the position's minimum qualifications. Tim Hoshal, AFSCME Staff Representative, states that AFSCME would be agreeable to this.

Motion by Councilor Peterson, second by Councilor Koivunen to Approve Letter of Agreement Between the City of Eveleth, MN and Base Unit, The American Federation of State, County and Municipal Employees, AFL-CIO, Local Union No. 484. Ayes – Mayor Vlasisavljevich, Councilor Peterson, Councilor Koivunen, Councilor Lillis; Nays – None; Abstain – Councilor Hadrava. Motion carried.

3. Approve Library Technician Hire

The hiring committee recommends the hiring of Mary Ellen Higgins for the Library Technician position contingent on acceptable background checks and AFSCME's agreement of item 3 above.

Motion by Councilor Peterson, second by Councilor Lillis to hire Mary Ellen Higgins for the Library Technician position contingent on acceptable background checks and AFSCME's approval of the Letter of Agreement Between The City of Eveleth, MN and Base Unit, The American Federation of State, County and Municipal Employees, AFL-CIO, Local Union No. 484. Ayes – All.
