9. Authorize city staff to post internally and externally if necessary to fill the vacancy potentially created by the opening for a Parks & Recreation Worker and/or other positions as they become available.

Public Works Director Rosati informed the Council that beginning November, the Public Works Department will be down an employee due to an extended sick leave and then proposed retirement.

Motion by Councilor Perpich, second by Councilor Koivunen to authorize City staff to post internally and externally if necessary to fill the vacancy potentially created by the opening for a Parks & Recreation Worker and/or other positions as they become available. Ayes – All.

10. Consider Facilities Use Agreement between the City of Eveleth and Independent School District No. 2909, Rock Ridge Public Schools

Mayor Vlaisavljevich said the agreements have been changing and apparently, they (School Board) do not care how much they pay. Money is not an object.

Councilor Perpich said the public has to know that the bidding war for hockey ice time was started by the City of Virginia. The City of Eveleth had a number of hours listed based on discussions held with Public Works Director Rosati, Councilor Perpich and the School's Athletic Director. The School had assured the City they did not want to take anything away from Eveleth. At that time the number of hours used was 300 which was based upon the School's use at the Hippodrome for last year's season. Now, the School is getting counter offers. Based on the City of Virginia and Iron Trail Motors agreement, the City of Virginia is stipulating that all hockey games (boys and girls) are to be played at the new Iron Trail Motors Event Center.

Mayor Vlaisavljevich said the whole proposal should be done again—fairly. City Attorney Lewicki concurred that would be the optimal solution.

Councilor Koivunen said that when you look at the dollar amounts it does not make sense. Eveleth's proposal was \$150 per hour. The City of Virginia proposed \$207 per hour.

Councilor Perpich stated that taxpayers in the Rock Ridge School District should not have to pay for a new convention center in Virginia. Perpich said that the parents of hockey players cannot hold the rest of the tax payers in the school district hostage by insisting they pay for hockey. The City of Eveleth has presented the school board with plenty of options.

Councilor Rauzi said he would like to see justification for paying that much more for ice time.

Councilor Koivunen questioned where the 500 hours came from. Director Rosati indicated that number was presented by the City of Virginia. Rosati stated that when the City of Eveleth started negotiations with the School Board, Eveleth used 300 hours. The City of Virginia is asking for 500 hours of ice time which was unknown to the City of Eveleth when negotiations started.

Councilor Koivunen said he would like to know the reasoning for the School Board only authorizing 150 hours to be played at the Hippodrome (with 350 hours authorized to City of Virginia to be played at the Iron Trail Motors Event Center). Koivunen said the taxpayer are the ones paying for this; not the School Board or the City of Virginia.

Motion by Councilor Lillis, second by Councilor Rauzi to table agenda item No. I.10. "Consider Facilities Use Agreement between the City of Eveleth and Independent School

District No. 2909, Rock Ridge Public Schools" and to authorize City staff, City Attorney and a member of the City Council to take steps to further clarify this issue with the parties in question. Ayes – All.

J. COUNCIL PRESENTATIONS/COMMITTEE REPORTS

Councilor Rauzi updated the Council on the HRA. Rauzi reported that there has been a governmental rate adjustment which will increase the rent.

Councilor Koivunen said the Golf Course will be closing in a week. He will soon be reporting on final financial figures and an update from the Golf Course Commission.

Councilor Lillis said there will be an EDA Meeting next week.

K. ADMINISTRATIVE PRESENTATIONS

Police Chief – Chief Linde reminded the public that calendar parking will be in effect starting October 1st. Councilor Rauzi asked about specific rules the police department may have regarding calendar parking. Chief Linde said anyone with questions can call the police department. There may be a future insert in the utility bills with a breakdown of specific instructions for residents.

Public Works Director – Director Rosati reminded the public that Fall Clean-Up is happening now. Councilor Perpich stated that the public should not be putting leaves in the street. Perpich asked residents to bag up leaves and yard waste for the Public Works Department to gather during alley pick up.

City Engineer – Alan Johnson, Benchmark Engineering, gave an update on the demo for 1104 McKinley Avenue. The Council awarded the project to G-Men. The contracts have been authorized for abatement. Johnson does not know the schedule yet, but will be attending a pre-construction meeting.

Johnson reported that City utilities for the Douglas street improvement project are near completion. The City's portion of the work will soon be finished.
